

Protection of data privacy

With your visit of this website, informations of the access could be saved.

This datas like time, date, IP adress, used Brwoser and the shown sites are non personal datas and will be anonymized.

This datas will only be saved for statistics.

A transfer to another party, for commercial or non commercial uses, will not be done.

The provider informs you, that communication through the internet (f.e. as communications by E-Mail) maybe got security savety vacancys and could maybe not secured for the access of other partys.

The usage off he contact datas off he impressum for industrial promotion is explicit not desired, unless the provider has given his written acceptance before, or there is already existing a business relationship.

The provider and all of his websites named persons contradict with this any commercial usage and transmission of your datas.

The provider informs explicit, that the transfer of datas through the internet (for example at communications by E-Mail) could have security holes and could not be protected without interruption by access of a third party.

The usage of contact datas of the impressum for industrial sales is not allowed, unless the provider has given his written acceptance and there is also an existing business relationship.

The provider and all of, on this website named persons, disagree with every commercial usage and transfer of your datas.

With the activation of the social media links trough the user, every user automatical agrees, that datas will be send to the provider of the social media networks.

Social Media Plugins

On our website we use (so-called) Social Plugins of the following social networks (named "social Networks" as followed):

- Facebook (Betreiber: Facebook Inc., 1601 S. California Ave, Palo Alto, CA 94304, USA)
- Twitter (Betreiber: Twitter Inc., 795 Folsom St., Suite 600, San Francisco, CA 94107, USA)
- Google Plus (Betreiber: Google Inc., 1600 Amphitheatre Parkway, Mountain View, CA 94043, USA)

In the interests of a preferably cover of your datas, the company Theimer und Mager GbR uses technical solutions, that ensure, that a data transfer through Social Plugins to the provider of a social network, should not be possible, without any previous activation of the Social Plugins through the user.

On our website, there are at the entry status deactivated Social Plugins integrated, that could not be able to contact the Server of Facebook or other providers of a social network, without a previous activation of the user.

If these deactivated Plugins will be activated from a user, if the user clicks on the end of the website to "Social Media activated", you automatically confirm the data transfer to the following named social media networks. After the activation, the Social Plugins connect to the relative social network. With a second click of the user, you could send recommendations within the relative social network. If you are already connected to a social network, maybe there will be not shown a further login dialog.

A click to the button "Social Media activation" means, that the user gives his agreement, that the relative named datas will be send to the relative provider of the social network.

This only affects to the at the moment opened website and the current selected Social Media provider. The agreement is valid for one Session and must be done again after a revisit of our website.

Our websites contains beside the Social Plugins as well some simple Links to Facebook, Google Plus and Twitter. A data transfer with the named Social Media providers is only available, if the relative Symbol-Button (for example the "f" of Facebook,, the bird-Symbol of Twitter, the "+1"-Symbol of Google Plus) is clicked on by the user. If you click on such a symbol, the website of the relative Social Media providers will be opened in a PopUp-Window. The user could send and publish informations of our products referred to the terms of the Social Media provider.

If the user activates a standard deactivated Social Plugin, a connection with the relative server of the social networks will be constructed. Every Social Plugin transmit datas to the relative social network. The provider of this websites got no influence of the range of the datas, that will be transmitted, with the help of the Social Plugin, to the relative social network. With our state of knowledge, the social networks receives informations of witch of our websites had been visited before by the user. Through each activated Social Plugin will be (on each call up) of the regarding website stored a Cookie with a explicit identifier. Hereby, the social network could be able to create a profile of your useage of act. It is not foreclose, that such a created profile could be assign to the user, if the user is creating later his / her first account on this social network.

If you are already registered (maybe as well logged in) on such a social network, if you are visiting our website, the provider of this relative social network could assign your visit your profile, if the user has the standard deactivated Social Plugins activated.

At the usage from Social Plugin-functions (for example "I like"-Button, delivery of a comment or "Tweets"), the information will be send over your browser directly to the relative social network and also saved. The same is meaned to a request of a website of a social media provider trough a click to the corresponding Symbol-Button.

If you are not a member of a social network, there is also existing the possibility, that the social networks (after activation of the Social Plugins) could get and save informations about your IP-adress, used browser and your used operating system. Scope and function of the data collection, as well the processing and the usage of the datas through the social networks and informations about rights and adjustments for the protection of the users privacy, must be reclaim by the user on the Protection of data privacy of the relative social network.
